Dear Friend of Physicians for Peace:

We'd like to extend warm thanks to the generous supporters of Physicians for Peace. For more than 25 years, PFP has made an enormous difference in the lives of patients in great need around the world.

2015 was a year of introspection and strategic realignment at PFP. A strategic planning process was undertaken, led by members of the Board and Staff, a committee of experts with vast experience in global health, surgery, maternal and child health, and international medical volunteer initiatives. The committee established achievable and transformative goals that will guide the organization over the next five years.

The major outcome of the strategic planning process was the consolidation of PFP programming to a refined medical area: building surgical capacity. PFP founder Charles E. Horton, Sr., MD, first brought people together in the operating room, teaching new techniques to health care providers on the ground more than 40 years ago. This renewed, singular focus on building local capacity and thereby forging relationships in surgical care is a logical continuation of Dr. Horton's pivotal founding work.

Statistics from the World Health Organization and others about the need for safe surgery in developing countries

are sobering. Five billion people lack access to safe and affordable surgical care, including anesthesia; every year 143 million additional surgical procedures are required in developing countries. PFP will continue to make a difference in training surgical workforces in our countries of focus, making our mission of "teach one, heal many" all the more resonant.

How will we do this? By integrating longer in-country stays for our International Medical Educators (IMEs), therefore maximizing their education and training impact. By leveraging state-of-the-art telementoring and telelearning technologies to better connect and support our IMEs with their trainees, both before and after in-country trainings. This expanded focus on technology will allow us to engage a larger group of U.S. volunteers who are anxious to contribute their skills and talents, but who may not be able to travel for extended periods.

As part of our strategic realignment, PFP has joined The G4 Alliance, comprised of more than 70 widely respected organizations committed to addressing the global health challenge in surgical and anesthesia care, and *training* the surgical care workforce to provide it. This is a partnership that we believe will help to ensure that we *are* truly making a difference.

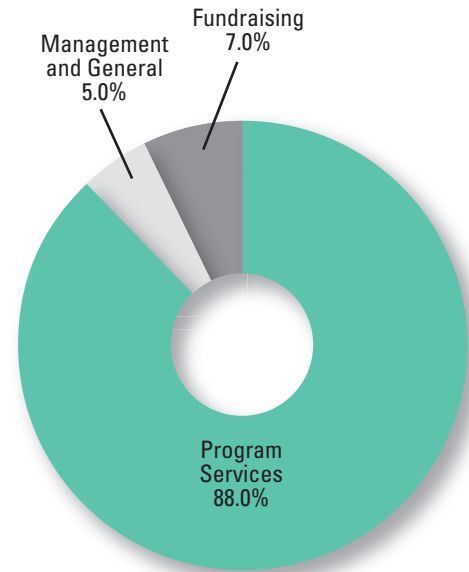
